

MISSON COMMUNITY ASSOCIATION 100+ CLUB CONSTITUTION

1. Name

The Misson Community Association 100+ Club will be known as the Misson Community 100+ Club and referred to hereafter as the MCA100+ Club. It will be run in compliance with the Gambling Act 2005 and licensed as a Small Society Lottery by Bassetlaw District Council.

2. Purpose

The purpose of the MCA100+ Club is to raise funds solely for use for the benefit of the Community of Misson Parish.

The usage of the funds so raised will be at the discretion of the Misson Community Association Committee although members of the community will be able to submit bids to the committee outlining their requests together with the costs involved. Information regarding the allocation of funding will be reported through the Misson Community Association website and Facebook page and the Missonhub.

3. Eligibility to participate and Administration

The MCA100+ Club is open to all residents of the Misson Parish together with members of the various Misson clubs/organisations. Participants are not limited to one number. The MPC100+ Club will be run by a nominated resident of the Parish who will report to the Misson Community Association committee.

4. Participation

It is the intention to sell a minimum of, but not limited to, 100 numbers each number costing £1 per month.

Participation shall be for a minimum period of 12 months from 1 September to 31 August. Eligible members may join and participate in the MPC100+ Club on payment of a pro-rata advance payment covering the period from the month immediately following receipt of their subscription and ending on 31 August either that year or the following year. People wishing to join with 6 months or less left in the current draw cycle will be required to pay the pro-rata advance payment together with the following 12 month draw cycle. Participation is dependent upon the MPC100+ Club having received a valid payment at least 7 days prior to the monthly draw.

5. Subscription and Withdrawal

Participation shall be by subscription payable in advance annually, by cash, cheque or annual standing order mandate. If withdrawal is to be made from the standing order mandate then the MPC100+ Club Administrator should be notified one month prior to the withdrawal. No refund of paid annual subscription shall be made.

6. Prize monies, Draw and Winners Payments

A minimum of 50% of the gross MPC100+ Club subscription income shall be disbursed in cash prizes with the balance being retained for use as outlined in Rule 2.

A monthly draw will take place on or around the 1st of every month and will be held in public. 10 draws will have 3 prizes as follows:

1st - £25.00

2nd - £15.00

3rd - £10.00

2 draws - one in July and one in December will have 4 prizes as follows:

1st - £50.00)

2nd - £25.00) Minimum but adjusted upwards as number of participants

3rd - £15.00) exceeds 116

4th - £10.00)

Should the number of participants fall below the required level to sustain the above prizes the 2 'super' draw 1st prizes will reduced accordingly.

Each winner shall be notified by telephone, e.mail or in person and paid in cash.

Details of the winners will be published on Misson Hub and on MCA notice boards.

If a winner cannot be contacted, the winnings will be placed into MCA funds after six months.

7. Number Allocation

Each participant shall be issued with a unique number which they will retain unless they withdraw from the club. There shall be no restriction on a winning member's allocated number being entered in subsequent monthly draws.

8. Personal Details

All personal details of participating MCA100+ Club members will be held by the MCA100+ Club Administrator. The details shall be confidential and used solely in connection with the draw.

9. Disputes

Any matter of dispute in relation to or arising from the administration of the MCA100+ Club will be referred to the full MCA committee whose decision will be final.
